Forest Area Federal Credit Union was organized on September 19, 1983. The original office of the credit union was located at Larr's Sporting Goods in Fife Lake, MI, until such time that an alternate location could be found. In January 1985, the office was moved to the original bank building in Fife Lake next to Kimball's Market. In December 1993, the office was moved once again, this time to its current location at 638 Boyd St. in Fife Lake. We opened our first branch office in Kalkaska, Michigan in 1987, to be followed 10 years later in 1997 by our Kingsley location (then moved to the East end of town in 2006). Our Manton branch was added in 2001.

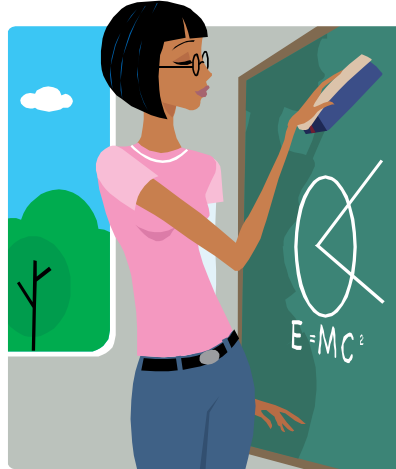
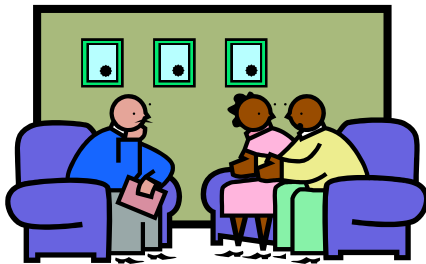
